"Step-Changes" in Business

New Strategic Creation (or Destruction) of L/T Values and Growth from

BoD's Critical Concerns

"Step-Changes" Significances

- Related to Strategic Objectives
- Into the Longer Term Future
- With Large Financial Impacts
- Undertaken with
 - New Organizations, or
 - Outside Partners (BD)
- In many cases, Sensitive and Confidential and could be Crisis-Like



BoD's Critical Concerns

Characteristics of "Step-Changes"

- High Risk / High Return / High Pressure
 - Out of Comfort Zones
 - Major Negotiations
 - > Tight Deadlines
- Require Comprehensive Knowledge / Experiences
- Difficult to Ensure Probability of Success
- Need to Work / Co-ordinates with 360°
